- Staffing: Of the three back grounds from the interviews, we reported last meeting were conducted 2 were discontinued and 1 was moved for a job offer. This is evidence that the new screening process by the County is working better than using the temporary agency, which was in place prior to the BOCC assuming operational responsibilities.
- Resident Care: We were able to work hand in hand with the Public Defender's Office and our Medical contractor TurnKey to ensure a recent placement in the community received some much-needed medication, not provided upon release. It was great collaborative effort that shows how things can work when we are working together to help the juvenile.
- Licensing: We continue our fast-paced grind to prepare for our OPI audit for licensing. September 11th is rapidly approaching.

- Technology: We have had multiple meetings with our County IT department in hopes of streamlining process. Those meeting were, Updating the camera system, digitizing our daily reports and moving to a records management System to eliminate paper forms.

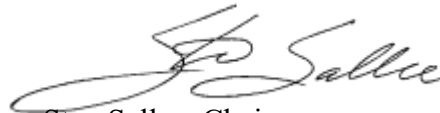
