 - Mattresses: The addition of new transparent mattresses that improve quality of life and comfort for our residents, removes all cracked and degraded mattresses to enhance sanitation and increases our security by eliminating an area to hide contraband.
 - Shower Curtains: Shower curtains, which are compliant with PREA standards, were installed to afford the residents privacy with the monitoring in place for security and safety of the residents.

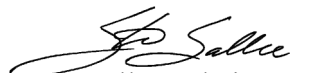
